Regular Board Meeting February 20<sup>th</sup>, 2023 7:00 p.m. Tioga High School Cafeteria

- I. Meeting was called to order at 7:00 p.m. by Board President, Paul Rodarmer Members present: Paul Rodarmer, Stacy Price, Dugan Rainey, Ryan Walters, Dallas Slay, Brandon Miller and Mica Bates
- II. Invocation and Pledge were led by Rickey Kemp
- III. Open Public Comments: Troy Mott, Bill Norwood, Ella Norwood, Heather Nesmith, Casey Cassell, Rachel Nalls, Trina Colteryahn, Kevin Colteryahn
- IV. Student Recognition
  - Lonnie Cooper Second year to make qualify for the State Cross Country Meet
  - 1<sup>st</sup> ever UIL Congress team in Tioga made it to the State Contest: Faith Tepfer, Lizbeth Fraire, Garrett Melson, Jessi Aguirre
  - Eight FCCLA teams advanced to the State Contest next month
- V. Interim Superintendent's Report
  - A. School Safety Grant Update: This has not been funded to date. There are a lot of school safety mandates coming out, most unfunded.
  - B. Budget Development & Deb Payments Update: Decision was made to pay all debt payments that were due on February 15<sup>th</sup> totaling @ \$1.8 million
    - 1.2M TAN from August
    - 555K Lease Purchase for High School
    - 48K UMB Bank & 37K US Bank for 2006 Bond for Elem/MS Budget development process was previously a 6-7-week process; will now be a 7-8-month process with complete transparency.
    - Decision was made to stay with the July 1<sup>st</sup> fiscal year
  - C. May Board Election Update May 6<sup>th</sup>, 2023 Candidates
    - Seat 1: Kelle Hinson, Rick Staples, Mica Bates
    - Seat 3: Ryan Walters, Shaun Pittman
    - Seat 7: Trina Colteryahn, Jamie Chamberlain
  - D. Enrollment Update: currently 710 students and holding steady. Our ADA is under 96% and this is where our school funding comes from, so we need this to improve.
  - E. Facility Projects Update
    - Thanks to the PTO for the fantastic Gala held this past weekend there will be an awning built where the student drop-off and pick-up is in the front of the Elementary/Middle School campus.
    - High School gym floor is being repaired ½ of the floor is being removed and replaced due to water damage and awnings will be built over doorways to help with water leaking into building.
- VI. District Update
  - A. Keith Kirkland Update for High School:
    - 8 teams (16 students) advanced to the FCCLA State Contest next month

- Basketball wrapping up and moving into our spring sports: Track, Golf, Tennis, Baseball and Softball
- Ag Department prepping for stock show season
- Stressed the importance of students being at school especially with so many out for extra-curricular activities in the spring.
- B. Athletics Report & National Academic Excellence Award 2A State Championship Mr. Ballinger reported that we will miss the Rogers family and the team effort on the balance between academics and athletics emphasis that apparent with the football team earning the 2A State Champions for the NFF National Academic Excellence Award.
- C. Agricultural Science Report

Jessica Sanders/Brad Bland presented update on Ag program

- In 2021/2022 Tioga ISD went from one Ag teacher to two Ag teachers doubling the number of classes available. There were 139 students enrolled in Ag classes that year.
- In 2022/2023 Tioga ISD now has 200 students enrolled in CTE Ag classes and has also added a dual credit Ag Science course.
- Estimated 30 students will take the Welding Certification test this year
- \$41K raised at the FFA/FCCLA Fundraiser earlier this month
- D. Business/Finance Report Sondra Hall
  - Update given on tax collection
  - Our Grayson County Property Tax total collections through the end of January 2023 are \$1,847,587.21. So far in February we have collected an additional \$318,788.34, Bringing our total collection to date to \$2,166,375.55. Leaving another \$254,004.28 to be collected.
  - December check register and deposit reports were distributed along with current bank account balances report.

- H. Discussed 4-Day School Week Calendar for the 2023-2024 School Year
  - Majority of teachers remain in support of the 4-day week; those not excited originally have changed their minds
  - Students have enjoyed being able to connect more with family and be at home more
  - Will proceed with creating 2 to 3 options to send out
- I. Motion was made by Stacy Price and seconded by Dallas Slay to approve the budget amendment(s) that require out of function adjustments allowing for the transfer of \$198,474.93 from the General Operating account to the Debt Service account. The motion carried unanimously. (7-0)
- J. Motion was made by Brandon Miller and seconded by Ryan Walters to approve with a single motion, the January check payments, bank financial reports and minutes from the previous meeting. The motion passed unanimously. (7-0)
