- IV. Superintendent's Report
- V. A. Campus Repairs, Improvements & Insurance Update:
 - Mr. Ballinger recognized several community member volunteers helping with repairs needed to our buildings.
 - Insurance claims have been started for the area at the elementary with ground water and roofing problems. TASB Risk has hired an engineering firm to evaluate further.
 - B. Board Member & Staff Trainings
 - Advised the board member had just completed the Team of 8 trainings along with other required trainings. The next training they will get will be in the Legislative Update in September.
 - C. Texas Legislative Update
 - Mr. Ballinger gave a brief overview of some of the items that will affect Tioga ISD from the recent Legislative Update. HB2 Homestead exemptions will take away from local contributions which means less money from Grayson County and more money from Austin.
