September 17, 2018

- I. Meeting was called to order at 7:04 p.m. by Board President, Rick Staples. Members present were Rick Staples, Rickey Kemp, Matt Roberts, Shawn Nesmith, Larry Hughes, and Paul Rodarmer. Board member Kelly Lintner was absent.
- II. Invocation and Pledge were led by Rick Staples
- III. Open Forum for Public Comments: Bob Harbold spoke in support of sidewalks leading to school.

- V. Dr. Holloway discussed the following:

  - D. Motion was made by Paul Rodarmer, seconded by Rick Staples to adopt the following statement: “Be it resolved that we as the Tioga Independent School Board of Trustees object to Nike’s support kneeling during our National Anthem at athletic events, we (Tioga ISD) will no longer purchase any Nike Branded/or marketed merchandise for use by our athletes and students.”

  - E. Motion was made by Rick Staples, seconded by Paul Rodarmer to approve update 111 with corrections to local policies DH and GKA to allow employee’s handgun to be loaded.

  - F. Information regarding formal annexation by City of Tioga was given. No action was needed.
  - G. Motion was made by Rickey Kemp, seconded by Paul Rodarmer to approve with a single motion the August check payments, bank financial reports, and minutes from previous meetings.  
Votes: 6 For 0 Against
